DATABEWUSTER DATA ADOPTION PODCAST & 12-WEEK PROGRAMME

2026

I help CDOs and data leaders to move within 12 weeks from a beautiful data and AI vision on paper to a supported data operating model in practice, without pouring yet another theoretical framework over the organisation.

- External and internal data podcast as an accelerator for adoption: As host of the Data Management Podcast, I interview CDOs and data leaders on governance, data quality and AI. I translate this format one-to-one into internal data adoption podcasts for clients: short, focused conversations with managers and key stakeholders that make data, ownership and responsibilities concrete and recognisable.
- In approximately 12 weeks, we go through a fixed framework with data awareness sessions and shared language: data strategy aligned to business goals, data maturity baseline assessment, design of governance & ownership, implementation of a pragmatic data quality management system (DQMS), final assessment and a concrete 90-day follow-up plan.
- Combining strategy, governance and implementation: I connect DAMA-DMBoK, Metro Model/DQMS and federated governance models with day-to-day practice in Power BI / Fabric, so that decision-making, roles and technical reality are aligned rather than working at cross purposes.

RESULTS FOR CLIENTS

- Board and management receive a simple narrative about data & AI (why, what and how) that they can repeat themselves.
- A concrete governance model emerges with roles, ownership and meeting structures that continue working after my departure.
- Data quality and definitions are made explicit and manageable, reducing discussions about 'which figures are correct'.
- The CDO / data leader strengthens their position as a trusted advisor rather than a reporting factory.

LANDAL

As a Technical BI Consultant at Landal GreenParks, I worked on the development of a new Finance and Operations reporting framework for management, controllers and park management. The existing reporting structure was largely based on Excel and legacy data logic, leading to limited transparency and maintainability. My assignment focused on redesigning the financial data model and developing a scalable Power BI reporting environment. In this role, I analysed and restructured the P&L structure based on the OneStream MPL hierarchy and integrated financial data from OneStream and NetSuite into a central data model. I developed a multi-level reporting setup where management gained insight through an executive dashboard, while controllers and park managers could drill down to general ledger level. By moving business logic from Power BI measures to the backend (SQL and data model), the performance and maintainability of the reports were significantly improved. In addition to the technical development, I worked closely with controllers, park managers and the management team to translate reporting needs into practical dashboards and KPI analyses. Workshops and feedback sessions were an important part of the process to make the transition from Excel-based reporting to a self-service BI environment successful.

DYCOTRADE

At DycoTrade, I was responsible for developing a future-proof Microsoft Fabric reporting environment for Royal Ingredients, based on data from Dynamics 365 Finance & Operations and Dataverse. I built the complete backend architecture, from bronze through to the semantic layer, and translated complex RDD documentation into robust fact and dimension models supporting multiple domains, including Finance, Trading, Logistics, Planning and Position Reporting. An important part of my role was unlocking D365 data via Azure Synapse Link to OneLake, which I then transformed in Fabric into a manageable Bronze–Silver–Gold architecture. I developed new business views, corrected missing data fields and resolved technical bottlenecks within pipelines, stored procedures and semantic models. In parallel, I worked closely with front-end developers and functional consultants. I ensured that the data layer fully aligned with the functional requirements in the RDDs, built optimised DAX calculations and determined together with clients and architects where logic belonged: in the backend or in the semantic model. My contribution laid the foundation for a scalable, maintainable and well-documented BI environment that formed the backbone for 11 strategic reports for commodity trading.

WATERNET

At Waternet, I was given the responsibility to establish data management across the entire organisation. Following a strategic decision by the board, I outlined the contours for a data governance model and took the first steps towards establishing a future-proof Data Office. I defined and described the various roles and responsibilities within data governance, mapped out data domain ownership and translated this into an advisory report to the board, with concrete recommendations based on DAMA-DMBoK principles. This laid the foundation for structural data management in the organisation. Because governance must not only exist on paper, I also took the lead in communication and adoption. I designed and managed a central SharePoint environment and developed communication materials that made data management understandable and accessible to diverse audiences. I also initiated my own data adoption project in the form of a podcast series, in which I interviewed managers and key stakeholders. This approach made governance visible, brought stories to life and stimulated organisation-wide conversation about data-driven working. In parallel, I led the implementation of the Microsoft Copilot 365 pilot for fifty users. For this, I conducted a baseline assessment of AI literacy, designed training programmes and developed an adoption strategy. This pilot was part of the broader movement towards digitalisation and governance, and strengthened the way Waternet leverages data and new technologies. Through this programme, I put data management on the map at Waternet: from an initial governance framework and data roles, to adoption formats and a concrete path towards a future-proof Data Office.

As a Business Intelligence Reporting Specialist at Enza Zaden, I contributed to the development and implementation of strategic and tactical dashboards within the Seed Operations department. Within this project, I actively worked on capturing uniform data definitions and governance frameworks, enabling the department to make more effective data-driven decisions. As a Technical BI Specialist at Van Oord, I played a key role in the development and implementation of the Founding the Future (FtF) Project Control Solution. Complex calculations in a custom framework caused poor performance. My ultimate responsibility was to resolve this. My work focused on designing and developing Power Query data pipelines, data models and reporting templates to provide an integrated overview of project control. This contributed to standardising and optimising Van Oord's project control processes. In my role, I developed a holistic Kimball data model that integrates the ten different knowledge areas of project management according to PMBOK guidelines. I designed and implemented user-oriented dashboards and reports in Power BI using DAX Studio and Tabular Editor for the Project Management Team and Business Unit and Corporate management. I also implemented methods for cost benchmarking and process optimisation to improve project forecasting and control. I contributed to both technical and functional documentation and developed user guides. Collaborating with the Data & Analytics team to ensure data quality and Row Level Security was an essential part of my responsibilities. Additionally, I provided training and support to Project and Cost Controllers to help them adopt a data-driven mindset and make optimal use of the new tools and reports.
